## 7. Revised Work Programme/Activity Schedule

The work programme/activity schedule prepared at the time of signing MoU between CDMP and UDD and revised work programmer/ activity schedule is attached in attachment I and attachment II respectively.

There are significant changes among major activities between the two work programme/activity schedules. This is primarily due to progress in the conceptualization of the project.
